## TOTARA PARK ADULT RIDING CLUB INC

**RULES OF THE CLUB** are in the Constitution, Conditions of Membership Agreement, Grazers Agreement, rally & riding Rules set by the Committee.

**SUMMARY OF** relevant Club Rules:

### **MEMBERSHIP & FEES**

- Membership is open to persons over 18 yrs. subscribing to Club Objectives and paying annual fees.
- The Committee may refuse to accept any applicant without giving a reason.
- Fees are due at the AGM each year. Membership must be applied for & renewed on the Club Registration Form accompanied by the yearly subscription fees. Members must Register and pay annual Fees by August 1<sup>st</sup> or they no longer hold rights of membership.
- Only current financial members may take part in Club activities (except on special invitation days). New members must pay fees prior to taking part in Club activities.
- Members may resign by notifying the Secretary in writing. A member may be suspended or expelled at discretion of the Committee for violation of Club Rules, Conditions of Membership Agreement, Grazers Agreement or for any conduct that is prejudicial to the interests of the Club.

### **RIDING & RALLIES**

- A standard safety helmet must be worn for riding or the member cannot take part (except for on Western rally days when an exemption Form from TPEC Trust must be signed).
- Bookings for all club events must be done through the organiser by Wednesday prior to the rally.
- 48 hours notice **must** be given to the organiser for any cancellation of bookings. Failure to do so will result in the full instruction fee being charged.
- There may be some special events or instructors which must be paid for in advance and are non-refundable. These will be notified in Whats On.
- If a Pony Club Rally follows our Rally we will clean up & vacate facilities half an hour before their start time.
- Events and Ribbon days may be run under special Rules of the Day as notified on the day.
- Prospective members are welcome to observe rallies or may attend one rally with their horse as a guest of a member; at the discretion of the rally organizer. (This includes instruction or practise days but not rides out or other Club activities). Ground fee must be paid along with any instruction costs.

### **CLUB AGREEMENTS**

**Conditions of Membership:**

**Working Hours & Attendance Agreement:**

- Members must carry out a minimum of 8 hours per year helping at any maintenance working bee, Club activity, rally, Club fundraiser event or by contributing to organising and committee work.
- Members must attend a minimum of 4 rallies per year, mounted or un-mounted or pay the Club levy.

**Grazers Acceptance Agreement:**

To hold a grazing position allocated to our Club, members agree to

- Remain actively participating & contributing regularly to Club activities,
- Help organize or run Club events,
- Take part in Club rallies & riding events, Members agree to take part in grounds working bees & carry out routine maintenance on the grounds. Membership may be lost, or rights to graze in a position allocated to the Club, may no longer be held, at the discretion of the committee, should these conditions not be met.

**Ground use:**

- We agree to respect TPEC Trust Rules when using the grounds.
- Rules & guidelines are notified to members when available from the Trust. Members must read & know these.
